The Kennel Club Cocker Spaniel Championship report

The 93rd Kennel Club Cocker Spaniel Championship was held Friday 5 and Saturday 6 January 2024 at The Kennel Club's Emblehope & Burngrange Estate in Northumberland. The Championship is generously sponsored by Skinner's Pet Foods, Sporting Saint Gundog Equipment Suppliers and the British Association for Shooting and Conservation (BASC).

Day one

Wolferton Candy, owned by His Majesty The King, started the Championship on the right hand side under judges Paul Rawlings and Gareth Davies. Handled by Ian Openshaw, the golden bitch worked across the white grassland, hunting up to a covey of partridge, one of which was shot and neatly retrieved.

Mick Walsh was next in with Mallowdale Jaffa, as the working line travelled across the hill towards the Alan Rountree Cabin and began working through the wide gully which runs below the cabin. The bracken filled valley proved fruitful and the left hand side of the line rapidly began moving down the running order. Mallowdale Jaffa was sent for a bird which couldn't be located by the dog or by the judges, moving on to complete his run on a loose bird which was shot and picked.

The wide gorge provided excellent viewing for the spectators and waiting competitors who looked down onto the working dogs from atop the heather covered hill. Breckmarsh Jana, owned & handled by Lee Cooper and Heathcroft Flyn of Tarncrag, owned & handled by Ms Fran Ardley both achieved tidy runs, both dogs flushing cock pheasants and retrieving well.

FTCh Delphaven Gina of Smallbrooks, owned & handled by Garret Marson came in on the right and was rewarded for her hunting efforts with a double flush on a pair of pheasants. As

the line of judges, guns, handlers and dogs neared the end of the gully, Garret and Gina had a retrieve on a loose bird. The line then rotated to head back to the start of the valley to take in the last area of uncovered ground.

Damien Kelly's Int. FTCh Clentohill Jessie Jay made a nice impact on her first run, achieving a flush on a cock pheasant which was brought down hard into thick bracken cover but was accurately picked by the bitch.

The line had moved more quickly through the even numbered dogs which were running on the left making the steward's role more taxing. As Garret Marson's run was concluded at number 11, FTCh Heathcroft Flora, owned by Mr Guy Stubbings, handled by Mr J Walton was brought in on the left at number 36, under judges Nick Gregory and Jeremy Davies. The little black dog completed her run with a nice flush and retrieve on a cock bird. The atmosphere in the gallery was jovial as the morning session drew to a close. The bracken filled gully

had produced multiple flushes and retrieves for the hard working little spaniels and everyone was looking forward to the afternoon.

Having been sustained by hot cups of tea and burgers kindly provided by Becky at The Game Cart, the handlers and spectators set off heading east into the rush filled paddocks. FTCh Mallowdale Flair of Endashaw, had a flush and retrieve just below the farmhouse. Owned by Mr Simon Dixon and handled by Mr Ian Openshaw, Flair was the second of six dogs handled by Ian in this year's Championship.

The next pair of dogs; Delphaven Fern, owned & handled by Mr Chris Slater in on the right, and FTCh Endashaw Desire, owned & handled by Mr Gavin Lockyer in on the left. Delphaven Fern had an efficient run, flushing and retrieving two consecutive hen pheasants.

Gavin Lockyer's neat black bitch had a fantastic run flushing two birds off the nose, the cock bird being hit and tucking in tightly into the verge alongside the track which was dutifully located and collected by the dog. She then successfully eye wiped the right hand side dog on a hen pheasant, completing her run by delivering her final retrieve on a hen bird neatly to hand.

The second round began on the left starting with dog 3 under judges Paul Rawlings and Gareth Davies. Mallowdale Jaffa, owned and handled by Mick Walsh hunted well as the line moved round the high stone walls crossing the paddocks, the dog flushing a hen bird and tidily retrieving.

His Majesty The King's Wolferton Candy was in next, handled by Mr Ian Openshaw and was brought across from the left to retrieve a partridge which had not been located by the dog on the right. Candy did a tidy job of the retrieve, eyewiping her running partner. The King's dog then completed her run on a flush and a retrieve on a cock pheasant.

Martin Deacon's black and white bitch; Woolpitts Lossie hunted her way across the rashes and was compensated for her hard work with a flush and retrieve on a hen pheasant.

Heathcroft Flynn of Tarncrag, owned & handled by Ms Fran Ardley had a flush and retrieve almost immediately as he was slipped off the lead and was hunted on, completing their run.

Simon Dixon's FTCh Mallowdale Flair of Endashaw, handled by Mr Ian Openshaw brought the first day's proceedings to a close with a solid flush on a partridge that was sitting tightly in the reeds. Though shot the hardy bird managed to slip through the stock fencing leaving the picker up with the final task of the day.

Day two

FTCh Mallowdale Flair of Endashaw, owned by Mr Simon Dixon and handled by Mr Ian Openshaw started the morning, being brought over to pick after a shot cock bird proved too much temptation to the dog on other side of the line. FTCh Baildonmoor Bielsa, owned & handled by Mr Paul Deal executed their first run well as the gentle breeze and light winter sun improved the scenting conditions, as well as warming the backs of the watching spectators.

Chris Slater's Delphaven Fern had a flush on a rabbit which appeared to take several barrels at as it sped over the crest of a small mound, however both dogs were sent and neither the spaniels or the judges could find the elusive bunny.

Woolpitts Lossie, owned & handled by Martin Deacon and FTCh Tiptopjack Firebug, owned by Mr Nigel Partiss and handled by Mr Ian Openshaw had a stylish retrieves across the beck which was flanked by bracken covered banks.

FTCh Woolpitts Shin of Poolgreen, owned & handled by William Clulee did a brilliant job of retrieving an elusive English partridge which had been flushed and shot on the other side of the line, and had tucked tightly into the bank of the bubbling burn. The spectators had excellent viewing as the line moved along the river's edge, the shaded bracken and white rashes still covered in morning frost.

Ant Myer's Popsheath Abbie hunted very stylishly, and the chocolate bitch made a lovely job of retrieving a large cock pheasant, completing her second run in the bright sunshine.

FTCh Uplands Bluebell of Badgerford, owned by Mr P Lewis and handled by Mr Will Clulee, was in at number 47 as the final dog of the first round. The black and tan bitch was sent across the burn and strongly retrieving the shot bird, eye wiping her running mate.

The breeze was increasing as the final few dogs were called into line, Lee Cooper's Breckmarsh Jana picked a loose bird from the left, then flushing a cock bird which was well shot by the gun team and neatly retrieved. Int. FTCh Clentohill Jessie Jay, owned & handled by Damien Kelly and FTCh Heathcroft Flora, owned by Guy Stubbings and handled by J Walton hunted the riverbank enthusiastically as Head Keeper Raymond Holt moved the line up into a sun filled valley. Gavin Lockyer's FTCh Endashaw Desire brought the Championship to a close as she hunted through bracken filled sheep crofts and finished her run with a flush and retrieve.

Presentation

Owned and handled by Gavin Lockyer, winning spaniel FTCh Endashaw Desire - known at home as Ria - was awarded first place in the competition to much applause from the crowd.

Amendments to Field Trial J Regulations

[NOTE: All regulation changes for the forthcoming season are listed in the back pages of the J Regulation booklets for reference]

The following regulation amendment has been approved and become effective on Friday 2 February 2025:

J8.b.(11) Control of dogs and competitors under trial

TO:

(11). ~~Only in cases of physical disability, and~~ **With the permission agreement** of the judges, ~~may a~~

handler **may** carry a stick whilst ~~working his dog~~ **competing**.

(Deletion struck through. Insertion in bold.)

(Effective from 2 February 2025)

Note: *Handlers may carry a stick, provided they ask the judges for permission before the trial commences. However, no handler should enter any trial if they do not have a good level of physical fitness required for the terrain they are on. Should a handler be seen by any of the judges to use their stick in an improper manner, appropriate action must be taken at that time.*

Update to the championship levy payment

At its recent meeting the Field Trials Committee agreed the following increases to the Spaniel and HPR championship levy payments, which will be in effect for the 2025/26 season.

HPR – increased to £50

Cocker Spaniel – increased to £75

Any Variety Spaniel (Excluding Spaniel [Cocker]) – increased to £100

Reminder and guidance to judges on completing the field trial judges evaluation form

As a panel Judge you are required to complete evaluation forms on your co-judges to assist the Field Trials Committee in making informed decisions regarding the suitability of candidates to join either the B or the A panel. The information gathered from these forms plays an important part in ensuring that only suitable candidates are approved, and this maintains the integrity and high standards expected of panel judges.

Regulation J(A)3.n. states that judges on the A panel and the B panel must submit assessments on B panel or non-panel judges, as appropriate, with whom they officiate. All evaluations forms to be received by The Kennel Club within 30 days of the trial.

Regardless of the judging system that has been used you must ensure that you make opportunities to assess the B or non-panel judges with whom you are judging. For example, you will have opportunities to assess their attributes such as attitude and politeness to officials at the start and end of the day and when you are discussing the dogs' marks you will be able to consider their ability to keep their book and how they handle differences of opinion.

As well as completing the questions on the form it is important that you provide additional comments as an overview of the person's performance. The more detailed the answers are that you provide the more assistance it gives. The opportunity to expand on any of the stated questions is there and you should try to take it. The additional information provided should fully explain anything which may be of significance to the Field Trials Committee in considering the candidate's nomination.

Standing over game

Following recent discussions, we would like to draw the attention of judges to the updated description of standing over game in the Guide to Kennel Club J Regulations for Retrievers document (previously named seminar script).

A good retrieve will include a quick and unfussy pick-up followed by a fast return. The handler should not have to snatch or drag game from the dog's mouth. Whilst Judges should not penalise a dog too heavily for putting game down to get a firmer grip, they must never, however, condone sloppy retrieving. A good game-finding dog should not rely on the handler to find the game. It should, however, be obedient and respond to its handler's signals where necessary. Dogs showing game-finding ability and initiative when hunting and retrieving should be placed above those which have to be handled to their game. Usually, the best dog seems to require the least handling. It appears to have an instinctive knowledge of direction and makes a difficult find look simple and easy.

Judges should reward tidy retrieving and good delivery. All too often Judges are to be seen with their books out writing a mark in the book before the game has been delivered to hand. Judges should watch the whole retrieve before awarding a grade and should penalise sloppy retrieving and bad delivery rather than taking clean retrieving for granted.

Game finding is of first importance but dogs should also handle well when required. Judges should not confuse a well-trained dog which handles well and easily with a dog which relies too heavily upon its handler in game finding. A dog should not be penalised because it can easily be handled to a fall, when others have struggled, and hunts for itself when it gets there. It should instead be given credit for the fact that it handles well. This should not be confused with the dog which requires continuous handling when it should not.

Equally, a dog should not be penalised for obedience if it had, for example, been stopped on the whistle by the handler on reaching the fall area, and it coincided with the dog being at the point of picking. The judges would have to make a decision whether the dog had already stopped to stand over the game (and eliminate) or it had stopped because it was obedient to the whistle. 'Standing over game' is when the dog finds the retrieve but instead of picking it stands over it, looking at the handler, waiting for an instruction. This should not be confused with dogs locating the game with a slight indication/point before picking a bird, especially if it is still alive.

Judging of partners or spouses

We would like to remind competitors and judges of regulation J12.a.(6), which states a dog may be disqualified if it has 'been handled at a trial, boarded or prepared for competition by one of the scheduled judges within the previous 12 months prior to the trial. This provision does not apply to judges appointed in an emergency'.

We would strongly remind competitors that it is not acceptable to run under a partner or spouse at a trial or working test, as there may be a perception that the partner or spouse had played a role in preparing the dog for competition.

This has been republished from the Winter 2022 field trials newsletter, with the addition that this should also apply to judging and competing at working tests.

Ownership of dogs

We wish to remind competitors that it is not an acceptable practice to amend a dog's ownership in order to gain additional runs in field trials.

Field trial application form and licences

We wish to remind field trial secretaries to use the online field trials application form where possible.
